

Quebec's tech ecosystem is now worth CAD99B

Since 2020, private tech companies have grown 3.9x, while the overall ecosystem has expanded 1.9x over the same period.



Public companies include those that exited through IPO or SPAC IPO. Companies which are public/acquired as of 2025 are included in the public/acquired cohorts from their founding year.

EV is the sum of the valuations of all startups in the ecosystem. Using estimated valuations based on most recent VC rounds, public markets and publicly disclosed valuations.



Quebec's ecosystem value is highly concentrated in Montreal

77% of Quebec's enterprise value HQd in Greater Montreal, 6% in Quebec City and 1% in Sherbrooke.

Sherbrooke has experienced the highest growth since 2020

Greater Montreal, as Quebec's largest startup ecosystem, has grown 1.8x since 2020.

Sherbrooke's growth was driven by [Entosystem](#), which raised CAD 79M in October 2024.

Ecosystem Value growth by Quebec regions (2020-2025)




Quebec is the third-largest ecosystem by value in Canada

Quebec's ecosystem accounts for 12% of Canada's total enterprise value.


Ecosystem Value of Canada by ecosystems


Quebec is growing faster than the Canadian average

Smaller ecosystems tend to grow faster. Quebec and Ontario are showing solid growth relative to their size, while British Columbia is significantly outpacing the national average.








Breakout VC approached an all-time high. Late-stage funding saw a slight recovery, though it remains below the eight-year norm whilst early-stage VC reached a decade-low


Early Stage VC





Quebec has raised more VC as a province than comparably sized OECD economies

A signal of growing investor confidence in Quebec's innovation ecosystem.


Quebec VC since 2020 benchmarked against similar sized economies*



Having built a solid VC foundation, now is the time to accelerate Quebec's growth trajectory

Quebec's venture capital activity declined by 0.81x since 2020—below the OECD average and behind most peers.

Quebec VC from 2020 to 2024 benchmarked against similar sized economies*




Nearly 60% of early-stage capital in Quebec is sourced in Canada

For comparison, in the US 80% of Early Stage VC is raised from American investors. This indicates that most of the value generated from the growth of Early Stage startups remains in the US - compared with Québec startups which retain roughly 20% value less for Canadian investors.





With the arrival of massive spending in infrastructure and defence in Canada, the last two years have seen a notable shift towards hardware and manufacturing.




Quebec VC by business model by time period Pre/During/Post Boom





Pipeline of Quebec companies by stage and Industry



Quebec over indexes in Enterprise software, Energy, and Travel compared with the average global VC allocation


VC allocation by total invested per Industry since 2020








2024 marked the third year on record with more than 20 exits

As acquisitions continue to dominate VC-backed exits, it suggests a trend of market consolidation, where established players are strengthening their foothold.

Public listings peaked in 2021 instead, after which activity has been scarce. This mirrors global trends and it's connected to change in interest rates and macro uncertainty in markets.

Universities are supporting the ecosystem, with over 80 spinouts valued near CAD600M





Methodology

What is a startup?

Companies designed to grow fast. Generally, such companies are VC-investable businesses. Sometimes they can become very big (e.g. \$1B+ valuation). When startups are successful, they develop into scaleups (>50 people), grownups (>500 people) and result in big companies. Only companies founded since 1990 are included in this report.

Unicorns are (former) startups that reached US\$ 1B valuation or exit at one point in time.

Dealroom's proprietary database and software aggregate data from multiple sources: harvesting public information, user-submitted data verified by Dealroom, data engineering. All data is verified and curated with an extensive manual process.

Venture Capital, Investors

Investment are referred to by their round labels such as Seed, Series A, B, C, ... late stage, and growth equity. VC investments exclude debt, non-equity funding, lending capital and grants.

Regional Breakdown

While many startups founded in Quebec relocate beyond its borders, most maintain business-critical ties to their homelands.

In order to take this reality into account, this report includes both Quebec-based startups, which maintain their main center of business (HQ) in their country of origin, and Quebec-founded startups, which relocated their HQ outside of Quebec.
